TERMS AND CONDITIONS
SIGN AND RETURN WITH RENTAL AGREEMENT

1. Definitions “Agreement” means all terms and conditions found in this form. “You” or “Your” means the person identified as the renter on this form and any persons signing this agreement. “We”, “Our” or “Us” means Gold Country Camper Rentals (GCCR) a registered LLC in California. “Camper” means the non-motorized camper trailer identified in this Agreement. “Loss of use” means the loss of our right to use the Trailer for any reason because of damage to it or loss of it during this rental. Loss of use is calculated by multiplying the number of days from the date of damage to the Trailer until it is repaired or replaced time the daily rental rate.

2. Rental, Indemnity, and Warranties. This is a contract for the temporary rental of GCCR camper. ***You agree to indemnify us harmless from all claims, liability, costs and attorney fees we incur resulting from, or arising out of, this rental and your use of the Trailer. We make no warranties, express, implied or apparent, regarding the Trailer.***

3. Campground Reservations. We are not responsible for campground reservations. All campground reservations must be made separately with the Campground’s reservation agency. All campsite fees are the responsibility by you.

4. Check In. Pick up times are generally between 2:00 pm and 5:00 pm daily and it is your responsibility to call us at (530)-744-7377 or email at goldcountrycamperrentals@gmail.com to schedule your desired time. Pick up times will be scheduled on a first-come, first-serve basis and we will do our best to accommodate your needs. Drop off by 12 noon on last day of rental. You will need a 2” ball for the camper hook up and a round 7 pin connector. If you have questions feel free to call us. We have some hitches and adapters if you would like to borrow one. Please note the gvw (Gross Vehicle Weight) and the tongue weight ratings for our campers and check your vehicle’s owner’s manual to confirm its ability to tow our camper.

5. Optional Delivery / Set up / Pick up. In pre-approved cases, GCCR will upon your request deliver and set up the Trailer at the camping location on the Rental Period Start Date and pick up the Trailer upon the completion of the Rental Period . Locations within a two hour drive are possible and extra charges will apply. This service has to be approved in writing by GCCR. Please contact us asap if you would like to add this service.

6. At the time of pick up, one of our staff members will provide you with an orientation to show you the safe and proper use of the Trailer and its features. Please watch the videos listed on our website to familiarize yourself with the set up and take down of the camper. It is not difficult to do when you are knowledgeable of the steps.

7. Insurance. Renter must have full coverage auto insurance in their name and accepts full responsibility for GCCR Campers. GCCR does not provide any insurance coverage for the camper and Renter is advised to contact Renter’s own insurance company/agent and add this coverage for the Rental Period Dates outlined in this Agreement.

8. Personal Injury. You release us, our agents and employees from all claims for injury, including without limitation, personal, bodily, or mental injury, economic loss or damage to you, guests, unborn children, or relatives.

9. Smoking. There is **NO SMOKING** in any of the Trailers. If the Trailer is returned with any kind of smoking odor, it will result a flat charge of \$200 plus any other additional charges incurred in cleaning and/or repair.

10. Pets. We love our pets and are a pet friendly company. Your dog is welcome in our camper, but please be prepared to vacuum or brush out all dog hair in the trailer. You are responsible for any damage they may cause.

11. Propane and Battery. We provide the propane tank set up with the camper and an additional full tank in the front storage area in the event you run out. The battery is charged for your usage.

12. Appliances. The lights, water, fridge, plugs, heater, A/C are convenience items. If any malfunction should occur with any of these items, **no compensation** will be made to you. You are advised to consult the informational material for assistance or contact GCCR at 530-744-7377. We do make every effort to provide our campers to you in good working order.

13. Renter Damage. If the Trailer and/or contents in the trailer are damaged during your rental period, you are responsible to pay all damage costs whether you were at fault or not or if damage was caused by acts of nature (wind, rain, earthquake, fire, flood, etc). If an accident occurs, you are responsible for obtaining a police report, contacting us immediately. Upon return, GCCR will note the damage and expeditiously get an appraisal of repair costs. If any repair or cleaning is required GCCR will expedite that cleaning and/or repair.

14. Early Departures/ Extending Rental Dates. You are responsible for reviewing this Agreement to ensure that all rental costs and rental dates are correct. If you wish to extend the rental period, you must call us for approval. There are **NO REFUNDS** for early returns. If you do not return the Trailer at the scheduled Rental Period End Date and you have not called us for approval to extend the rental period, you will be charged additional rental day(s), and any inconvenience fees incurred by the next renter.

15. Waiver. Our failure to enforce any of our rights under this Agreement or at law shall not be deemed a waiver or a continuing waiver of any rights or remedies against another party, unless such waiver is in writing and signed by the party to be charged.

16. Modifications. No term of this Agreement can be waived or modified except by a writing that we have signed.

17. Entire Agreement. This Agreement constitutes the entire agreement between the parties regarding the rental the Trailer, and supersedes all prior oral or written agreements or understandings regarding this subject matter. This Agreement can only be amended by a writing signed by all parties.

18. Refunds. No refunds will be given for any reason, including, but not limited to, bad weather, no shows, late arrivals, or early returns. If you cancel your reservation in writing within 30 days prior to the start date, GCCR will refund 50% of your charges. If you cancel within the 30 days prior to your reservation you will forfeit your payment in it's entirety. If you wish to reschedule there will be a \$50 rescheduling fee and this must be done within 12 months of the original reservation, with no loss of the original charges.
